Two are better than one because they have a good reward for their toil. For if they fall, one will lift up the other, but woe to one who is alone and falls and does not have another to help. (Ecclesiastes 4:9-10)

I've been very pleased with our Constitution Conversations. Members of both congregations are making an effort to participate; good ideas are being shared and relationships are being strengthened.

We've read through and discussed the proposed constitution for our blended congregation, so people can have a better understanding of the power and responsibilities of the voting members of the congregation and what power and responsibility is delegated by the congregation to the elected members of council.

A number of constitutional bylaws have been proposed by conversation participants; they have been forwarded to synod staff for review. If approved and ratified by the congregation, these bylaws will clarify the criteria for being a voting member, keep the congregation better informed about the work of the council, and give the council a procedure for replacing people who resign from it.

The "Plan of Merger" drafted by our lawyers has been thoroughly discussed. It describes how Hope Lutheran will cease to be an ELCA congregation but continue to be a not-forprofit corporation in the State of Florida; this is necessary in case someone has made Hope the beneficiary of their estate.

On the day we ratify this document and our new constitution, all of the members of Hope will automatically be made members of Trinity. Hope's checking and savings accounts, which hold all of their remaining financial holdings, will be closed and the funds transferred to Trinity. The only exception to

this would be if we decided the "legal corporation" of Hope needed to keep a small amount of funds in an independent account.

We will continue to own and operate two church facilities; at our congregational meetings in November, we voted to merge the members before making decisions about property. My desire is for us to have all of our members worshiping together at one Sunday service as soon as possible, moving back and forth between the two sanctuaries.

For a few months, our two seven-member church councils will be combined into one. Fourteen people is a lot for a council, but they will have a lot of work to do to prepare for our first Annual Meeting as a merged congregation: deciding how large the council should be, drafting a budget, and making decisions about the paid staff.

A questionnaire was sent to the voting members of both congregations, asking how prepared they felt for the merger, what information would make them better prepared, and when they wanted the vote for merger to take place. An overwhelming majority have expressed a readiness to merge as soon as possible.

Some people have said they'd be better prepared for the merger vote if we had "full agreement" on all of the challenges we face. Realistically, I don't think that is possible; my prayer is that the bonds of love and respect that we are forming will enable us to make decisions and cope with inevitable changes, recognizing how God has brought our two congregations together at this time for a purpose.

The Beauty of Stewardship

Stewardship has to do with how we manage our time, talent, resources — basically our entire lives. It's a beautiful concept when properly understood. Here are the basics of good stewardship:

God is the source of all creation, including our lives.

God is the primary owner of all that exists.

We are blessed by being given the task of managing well all that we have influence over: our lives, our abilities, our minds and bodies, our time, our part of the earth, our finances, our children, our church buildings, our automobiles, etc. Although we can make decisions regarding each of the above, ultimately we are responsible to God. Sooner or later, we must give an account of our management of God's creation and of God's gifts.

When we properly use the talents, resources and property that God allows us to manage, we find great joy. Think of planting a garden which soon overflows with colorful flowers, wonderful vegetables and flavorful herbs, etc. God gave us the plot of ground, God gave us the seed, God gave us the wisdom and strength to bring forth such beauty, such good things to see or eat, or smell. Yet we did the

work, with God's help, to make it a reality. Like Adam we tilled it and kept it. But God gave the increase. God's provisions and our labor brought the garden to its fulfillment.

Good stewardship enables us to do something positive and wonderful with the money God has allowed us to have. What feels better than knowing one has managed money well? Our bank account, our checkbook and our portfolio tell the story. When money is handled well, we have enough for ourselves and are still able to give to God's work.

That is the beauty of stewardship.

Will The Circle Be Unbroken

Prior to the official founding of bluegrass in 1940 with Bill Monroe and his Blue Grass Boys, the genre was a melting pot of culture that drew influence from Celtic folk music, Southern life, and, most prominently, religion.

Since religion was one of the main contributors to the birth of the genre, one of the most iconic and notable bluegrass songs is the 1907 gospel hymn "Will the Circle Be Unbroken." The more than 100-year-old gospel hymn was originally written by Ada R. Habershon, with music composed by Charles H. Gabriel. Habershon was an English physician, religious author,

and, most notably, a Christian hymnist who incidentally gifted bluegrass and country one of its quintessential songs.

The epochal tune became a staple of the genre thanks to the first known cover of it by the Carter Family in 1935, in which the hymn was loosely rewritten and retitled "Can the Circle Be Unbroken." The song's timelessness was also reinforced by the Nitty Gritty Dirt Band's 1972 cover of the song on their album *Will The Circle Be Unbroken*. An abundance of other artists who have covered the song are Bill and Charlie Monroe, Willie Nelson, Bob Dylan and The Band, George Jones, The Avett Brothers, and even The Doors.

Regardless of the celebrity covers and the minuscule rewrites of the song, the pinnacle reason why this song has been able to transcend the test of time is due to the honesty and truth embedded within the meaning of the 116-year-old lyrics.

The Meaning in the Lyrics

Like many songs, the intended meaning of the lyrics has been interpreted and digested in numerous different lights. Though, an undeniable fact is that the lyrics pose themselves as a lament and or a funeral dirge. Within these

grief-stricken lyrics entails an awfully daunting question, that question being: When you close your earthly story / Will you join them in their bliss? In other words, Habershon is seemingly asking whether or not one will continue the cycle of being a righteous human being and rise to heaven after their death in order to meet the rest of their family.

An existential question of vast enormity that is further bolstered by Habershon's lyrics, as the following verses deliver a poignant sense of melancholy with lines such as: Is a better home awaiting / In the sky, in the sky, as well as Do you love the hymns they taught you /Or are songs of earth your choice?

Habershon stays in the context of grief and poses the sentiment in a visceral metaphor that embodies the song's title through the image of a campfire circle. As the lyrics go, You can picture happy gath'rings / Round the fireside long ago, and, One by one they went away / Now the family is parted / Will it be complete one day? Meaning, will the ones still present on the earth be reconnected with their dearly departed family members in the afterlife, thus completing the fireside circle.

On the contrary to the song being about the reconnection of family members, another meaning that Habershon may or may not infer is: will the one break the cycle by succumbing to the sin of the earthly world crawling to the depths of hell? This reading of the song is often overlooked by listeners, and musicians covering the song, as it does not support the uplifting message that the lyrics lend themselves to.

Whether or not Habershon intended for that interpretation, that is one of the beautiful elements of the song: that the lyrics are concisely vague enough to offer both an evident head meaning, as well as room for subtextual interpretation that provides a multiplicity of meanings for the listener.

Mission Movement Discussion and Decisions:

⇒ City Church:

- The pastor from City Church, Justin Woodall, joined us to share an urgent message: they need a new to place to worship in the downtown area.
- Currently, they are renting space at the Sundial AMC
 Theater for \$4000 per month. In the very near future,
 they expect to be receiving a 30-day notice to
 evacuate. They are seeking temporary space for
 worship and 4 rooms for Sunday School classes.
- The council unanimously voted to allow them to use our facility.
- Specifics and contracts have yet to be drawn up; that will be the next step.

⇒ Mission Property Group (Foundry):

- Specialize in helping non-profits, primarily churches, with real estate.
- Start with <u>mission first</u>. They believe that the vision and mission of the church should drive real estate decisions and it will be through that lens that real estate decisions are evaluated.
- Have worked with ELCA churches across the nation; they are a resource for our Florida-Bahama Synod.
- Will provide a real estate review/assessment of both properties, including general positioning, potential marketability, pros/cons, etc.
- There are no upfront costs for this evaluation work; any commissioning would take place if/when selling is involved.
- Both councils unanimously decided to proceed with asking them to support us; the Vice President of that company will be meeting with both the councils and congregations of Trinity and Hope prior to any actions.

Hope Council Highlights

Solar Update-Robert Hamilton: The roofers will begin work on Monday 9/22 on the CommUNITY Room roof and on or around 9/29 they will start the flat roof. That will be complete by 10/13 for the solar installation. The second payment will be due before the roof completion date. The first payment was 35% the second payment will be 40%. The back parking lot will be shut down during the time they are working. The first Friday dinner will be in the gap. The preschool has been informed. People will be encouraged to park in the grass. By the end of November all should be finished. Robert, Harold, Roma and Angie will meet about the IRS stuff.

Merger Update: Alan Due was present to share merger information. He proposed that we use an unbiased Faith Based company called Foundry Commercial Mission Property Group (FCMPG) that specializes in helping churches and non-profits. After discussion, the decision was made to go forward with having this company proceed with the assessment and report back with their findings.

Treasurer's Report – Roma Heystek:

We are hanging on, but we will still need more funds for the solar project. A concert is being planned as a fundraiser for this project.

A chart will be created to reflect our fundraising progress.

Support for the Unhoused – Tom Herzhauser:

- Allow access to resources like outlets to charge their phones and safe cover to keep out of the rain?
- Betty suggested posting up a list of resources for them within a mile radius around the campus. Angie will research resources.
- Tom and Angie will work on creating a policy.

Secretary/Office Report—Angie Pryor:

 Grace Family Church is now holding their Thursday night Bible Study every week. Tom & Angie will meet with Pr. Kody to discuss how they can give back for the use of the space.

Facilities/Maintenance - Gary Bartelt

The memorial garden needs to have an invasive Brazilian Pepper Plant removed.

Perhaps we can also add some plants that will attract butterflies.

Pastor's Report - Pastor Paul Gibson:

Things are going well with our blended worship, events, and conversations. We hope to be able to have a vote in October (no date set at this time) regarding constitution, bylaws, and the plan of merger.

Thrift Store Report – Pat Shipley:

- The Thrift Store: \$3669 year to date!
- We have been giving larger sized clothes to Clothes to Kids and another organizations for special needs youth, because there is such a need.

Additional Items of Interest:

- Approved to let a Meadowlawn neighbor park an RV on church property until it sells. He has already been making a monthly donation to the church in exchange for our letting him park his truck on the property.
- Discussion around storage of choir materials in the sanctuary/altar area.
- Ongoing issue of memorial garden nameplate being taken. Solutions being explored.

Fortunately, they were very easy babies, grew into great campers, did awesome in school, and are now doing well on their own. Chris is a dentist in Asheville and Lisa started out as an electrical engineer working on the space shuttle and then went to Sydney, Australia to get her Master's Degree in biomedical engineering working on developing an artificial retina. She married Justin, an aerospace engineer and they live in Maryland. Thanks to them, I am grandma to the "smartest kid in the world". Celeste is 9 going on 19!

When Chris and Lisa started kindergarten, I went back to teaching, but in Pinellas County. I had been a teacher for 40 years when I felt I was burning out. Retirement has agreed with me! Many of you may not be aware of the story of "Be like Bert" in our monthly newsletter.



Doing God's Work

TARPON SPRINGS, Fla. The Church on the
Bayou Presbyterian
Church, a Tarpon Springs
landmark since 1888, is
shutting down after
suffering repeated
hurricane damage.



Hurricane Helene flooded its sanctuary and fellowship buildings last year. Hurricane Milton followed with destructive winds and rain that tore through skylights and caused extensive leaks.

Already facing declining attendance and the retirement of its lead pastor, the congregation decided to sell its five-acre property on Whitcomb Bayou to another church for \$2.4 million.

For decades, The Church on the Bayou served as a safe gathering space for Tarpon Springs residents. Members worshiped outdoors during the pandemic and hosted milestone events, memorials, and community services on its campus along the Anclote River.

Longtime member and Treasurer Susan Conrad said the decision to close was heartbreaking, but the chance to give back made it meaningful. She said, "People talk about, it's so sad that this is closed. But then had we not sold this, we would not be able to do what we're doing."

Instead of holding on to the proceeds, church leaders chose to channel the money back into the community. They have begun distributing funds to 22 local schools and nonprofits, including:

- \$25,000 to The Salvation Army
- \$500,000 to The Shepherd Center
- \$30,000 to Dr. Martin Luther King, Jr. Event & Scholarship Foundation
- \$50,000 to Hero to a Child
- \$25,000 to Tarpon Springs High School

Upcoming donations include \$40,000 to St. Andrew's Presbyterian Church and \$150,000 to Tarpon Springs Elementary, one of the city's lowest -income schools. That money will go toward classroom supplies, a clothing closet, and a new playground.
